If you are a UK tax-payer, the Parish can reclaim a tax rebate equal to 25% of the amount you donate, and at no extra cost to you, so if you give £10 to the Parish, we can reclaim £2.50 and it still only costs you £10. This is a very important additional source of income to the parish, so please register if you are a UK tax-payer and have not already done so.



Most people who give by standing order have already registered for gift aid – if you have not already done so, or are unsure, please see the gift aid coordinator. If you contribute through the parish website, you can register online. If you contribute using contactless, you can <u>either</u> register on the machine after you have made a qualifying donation, <u>or</u> use the QR code to register your card in the privacy of your home using your smartphone, tablet or PC.

Once you have registered your details, every donation you give using that method will be automatically gift-aided without the need for you to enter your details again. Finally, if you are a higher-rate tax payer, please remember to reclaim the personal tax refund to which you are entitled, which means a lower overall cost to you.


